
**ORDER MODIFYING AUTOMATIC STAY
WITHOUT NOTICE**

This matter came before the Court pursuant to a conversation between the Court and the Honorable James M. Marlar, United States Bankruptcy Judge for the District of Arizona ("Arizona Court"), the Arizona Court reciting that the above case was filed as part of a pattern of serial filings to inhibit the administration of the bankruptcy case of In re Norma J. Hurt, No. 85-3802-JMM, and adv. pro. 99-605 (Hurt v. Wakefield Properties, Ltd.), both pending in the United States Bankruptcy Court for the District of Arizona. Having considered the recitations of interference and obstruction of the administration of the Arizona Court and of the consequent inability of the Arizona Court to perform its functions, this Court finds good cause to modify the stay for cause (11 U.S.C. section 362(d)(1)) based on the authority of 11 U.S.C. section 105, and to do so without notice to the debtor in possession or its counsel.

IT IS THEREFORE ORDERED that the stay is modified to permit the bankruptcy case of In re Norma J. Hurt, No. 85-

3802-JMM, and adv. pro. 99-605 (Hurt v. Wakefield Properties, Ltd.), both pending in the United States Bankruptcy Court for the District of Arizona, to go forward immediately.

IT IS FURTHER ORDERED that the stay provided by Rule 4001(a)(3) shall not be and is not in effect for this order.




